### Save the Date: the 2021 LFP National Conference

The 31st annual LFP <u>National Conference</u>, *Science, Faith, and the Common Good*, will take place on the campus of <u>Boston College</u>, October 8-10, 2021.

At this year's Lilly Fellows National Conference, we will come together to explore the fruitful ways in which science and religious faith can mutually enrich one another. Although there has been a long history of animosities between science and religion, in this conference we will hearken to voices witnessing to their compatibility and cooperation. We will ponder how this reinvigorated conversation and cooperation can benefit the common good of humankind – what Pope Francis called "care for our common home."

This theme is most appropriate, as the Lilly Fellows Program has begun a new stage of its mission. Branching outward from many years of conversations focused on the humanities and arts, the Lilly Fellows Program is

now developing new models for integrating faith, higher learning and research in the fields of the natural sciences, social sciences and professional disciplines through its Faculty Fellows Program.

At the same time, Boston College has inaugurated its <u>Schiller Institute for Integrated Science and Society</u>, using science and technology to search for solutions to society's most pressing challenges, while educating the next generation of science leaders in the areas of energy, health and the environment. These are the goals of its new interdisciplinary initiatives and undergraduate majors in "Global Public Health and the Common Good," and "Human Centered Engineering."

Speakers include Stephen M. Barr, Professor Emeritus in the Department of Physics and Astronomy at the University of Delaware; Thea L. James, Vice President of Mission and Associate Chief Medical Officer at the Boston Medical Center, and Nancey Murphy, Senior Professor of Christian Philosophy at Fuller Theological Seminary

Registration will open in May 2020.

### The 2021 LFP Virtual Consultation for Senior Administrators

In place of the annual Workshop for Senior Administrators, on Tuesday, March 23, from 2:00 to 3:30 pm Central Time, the Lilly Network will provide an opportunity for senior administrators of Lilly Network Schools to meet together virtually in small groups to address the theme: *Racial Injustice and Church-Related Colleges and Universities*.

Since last spring, colleges and universities have been more intensely engaging the national discourse about race and injustice. The killings of George Floyd, Breonna Taylor and others, the inequities exposed by the pandemic, the rise of white nationalism, and the lingering unrest over immigration and systemic racism have prompted both unrest on campuses and more deliberate debates about curriculum, equity, and inclusion.

With this in mind, our virtual consultation will address the question: In light of this historical moment, how have our campuses addressed racial injustice over the past year? What have we learned about ourselves and our institutions, and what hope do we offer our communities and stakeholders? Specifically, we will address such questions as: How do our institutions' histories, traditions, missions, and guiding ethical and theological ideals: (1) Offer resources for understanding of and response to systematic racism in our nation? (2) Help us interrogate and understand our own institutions' relationship to racial injustice? (3) Impede such investigations? (4) Cultivate hope and provide resources for justice for our institutions and broader communities?

I urge you to attend this consultation or to pass this information along to other administrators on your campus. Participation in and registration for this consultation is offered only to senior administrators at Lilly Network member institutions. Each institution is eligible to register one senior administrator (president, vice president, academic dean, provost, or equivalent). Additional participants from member schools will be waitlisted until March 11, 2021 and will be added as slots become available. *Please note, we anticipate that this consultation will fill to capacity well before the registration deadline.*

# Call for Nominations, The Ninth Biennial Lilly Fellows Program Book Award for 2021

The Lilly Fellows Program invites nominations for the <u>ninth biennial Lilly Fellows Program Book Award for 2021</u>. The biennial Lilly Fellows Program Book Award honors an original and imaginative work from any academic discipline that best exemplifies the central ideas and principles animating the Lilly Fellows Program. These include faith and learning in the Christian intellectual tradition, the vocation of teaching and scholarship, and the history, theory or practice of the university as the site of religious inquiry and culture.

Works under consideration should address the historical or contemporary relation of Christian intellectual life and scholarship to the practice of teaching as a Christian vocation or to the past, present, and future of higher education. Single authored books or edited collections in any discipline, published in 2017 to 2020, are eligible. The committee will receive nominations of academic faculty, clergy, and others. Authors or editors cannot nominate their own works. A Prize of \$3000 will be awarded at the <a href="Lilly Fellows Program National"><u>Lilly Fellows Program National</u></a> <a href="Conference">Conference</a> at Boston College, in October 2021. The deadline for nominations is **March 1, 2021**.

# Call For Papers: Upcoming Virtual Regional Conference at Azusa Pacific University

You are invited to submit a proposal to the conference, <u>Reckoning and Reimagining: Envisioning a Faithful</u>
<u>Presence in the Liberal Arts</u>. This two-day virtual (live and pre-recorded) conference is funded by the Lilly Fellows Programs, hosted by Azusa Pacific University, and is free of charge to registered participants.

#### Key dates:

- **February 1, 2021:** Call for proposals opens
- March 1, 2021: Call for proposals closes
- March 15, 2021: Proposal notification and registration opens
- April 15, 2021: Pre-recorded presentation deadline
- May 26-27, 2021: Conference

The Conference Committee is inviting submissions of proposals for 10-minute pre-recorded presentations addressing one or more of the following themes described below. The one-hour presentation sessions will have four pre-recorded 10-minute presentations, followed by 15 minutes in which the four presenters respond to participants' questions.

#### The Four Conference Themes:

- **Health care:** How does scholarship help us understand medical, social, and psychological challenges for creating a more equitable health system?
- **Economics:** How does Christian scholarship address the support of human and economic flourishing of communities trying to rebuild?
- Anti-racism: How can we work to address a legacy of racist policies and practices in our nation, especially in light of the COVID-19 pandemic?
- **Socio-politics:** How might we better understand the complex and diverse ways in which Christians in the U.S. navigate social and political action?

## **Recent LFP Mentoring Grants**

Mentoring Programs have been among the most popular and successful of all LFP initiatives. Mentoring Programs provide funds to nurture new and junior faculty at Network institutions and strengthen the commitment of all faculty to institutional mission. Well-constructed mentoring programs encourage new faculty as well as veteran faculty to understand and share the ethos of the school, to grow to love the questions that the institution holds dear, and to consider the importance of fundamental matters concerning the relationship between higher learning and the Christian faith. Such programs also seek to renew and deepen the commitment of the whole institution and its leaders to those central intellectual and spiritual matters. ## **Recent LFP Small Grant Programs**

The Lilly Fellows Program National Network invites Network institutions to apply for <u>small grants</u> of \$3000 to stimulate conversation about church-related higher education and church-related mission on their campuses or among church-related institutions in close proximity to each another. The LFP hopes these grants will extend and strengthen the LFP's national conversation about church-related higher learning and mission within and

among our network campuses. The Small Grant program is designed to fund new programs on network campuses rather than supplement ongoing ones. The current deadline for the submission of applications for the 2022-2023 academic year is September 15, 2021.

In 2019/2020 the LFP National Network Board awarded Small Grants for the academic year 2020/2021 to <u>Saint Louis University</u>, <u>Saint Mary's University</u> (MN), <u>Villanova University</u> (postponed to 2021) and <u>Loyola University Maryland</u>.

In spring 2020, the LFP made a special call for small grant programs to address COVID-19 and issues of racial injustice sparked by events over the summer. At its fall 2020 meeting the LFP Board funded grants for these activities, most of which have already begun, for the following Network Schools: <a href="Azusa Pacific University">Azusa Pacific University</a>, <a href="Belmont University">Belmont University</a>, <a href="Dordt University">Dordt University</a>, <a href="Indiana Wesleyan University">Indiana Wesleyan University</a>, <a href="Sacred Heart University">Sacred Heart University</a>, <a href="Sacred Heart University">Saint University</a>, <a href="Sacred Heart University">Samford University</a>, <a href="Secrenton">Secrenton</a>, <a href="University of Dayton">University</a> of <a href="Dispersion Pikeville">Pikeville</a>, and <a href="Westmont College">Westmont College</a>.

# Recent LFP Regional Collaborations and Conferences at Sacred Heart University, Seton Hall University, and University of Pikeville

From the 21st to the 23rd of October 2020, the Institute for Communication and Religion (ICR) at Seton Hall University hosted a Lilly Fellows Program Regional Conference entitled "Communication and Religion in the '20 Election." Approximately 2500 viewers attended six events broadcast live online including a Presidential debate watch party and keynote addresses from leading scholars in Political Science, Religion, Journalism, and Communication. Heidi Campbell (Texas A&M) shared research on "Internet Memes and American Civil Religion," Ronald C. Arnett (Duquesne University) spoke on "Practices that Matter: The Faith and Politics of Dorothy Day," Rob Pallitto (Seton Hall University) shared expertise on "Trump, the 2020 Election, and the limits of Ideology Theory," and Jo Renee Formicola (Seton Hall University) addressed "Catholics, The Media, and the '20 Election." The final program "Judaism and Christianity in the '20 Election" was co-presented by Jon Radwan (Seton Hall University, ICR Director) and Peter Beinart (CUNY, The New York Times). Audience questions were answered at all sessions and remaining queries were covered in a follow-up interview with Ronald C. Arnett conducted by Asya Robinson (Seton Hall University). Video recordings of all sessions have been posted to SHU's YouTube channel and can be accessed via the ICR website. ICR Director Jon Radwan reported strong positive feedback and expressed gratitude for LFP support. "We had originally planned a physical conference for April 2020. COVID made us re-design everything for a virtual format, and the results have been overwhelming! We reached at least ten times as many viewers than we first anticipated, and our post-event survey results are very encouraging. We greatly appreciated Regional Conference funding from the Lilly Fellows Program, and we are especially thankful for the flexibility and understanding that enabled rescheduling online. SHU's motto is 'Hazard zet forward' and LFP encouraged our intrepid spirit with wonderful support as we met pandemic challenges."

On October 29-31, 2020, Sacred Heart University, in partnership with the Lilly Fellows Program, the Association of Catholic Colleges and Universities, and Seton Hall University, hosted a virtual Regional Conference titled The Catholic Intellectual Tradition: Challenges and Opportunities for the Catholic University in the 21st Century. Speakers included: Gregory Kalscheur, Boston College; Carolyn Woo, Purdue University; Michael Higgins, Sacred Heart University; Fr. Dennis Holtschneider, President of the Association of Catholic Colleges and Universities, and Gerald. J. Beyer, Villanova University. The aim of the Conference was to generate a wide, broad conversation about how the Catholic Intellectual Tradition (CIT) could provide a 'compass across the college or university' to promote and imbue the Catholic identity and 'ethos' of an institution There were panels on Catholic identity, Catholic thought, on the CIT across disciplines, on pedagogy, on programs, on the Catholic Imagination, on social justice, on student life, and from the perspective of the VPs for Mission. On February 19, 2021, <u>University of Pikeville</u> hosted an online conference titled *Higher Education's Moral Obligation of Addressing Addiction:* A *Humanities Response*. Today as almost 21 million Americans are addicted and drug overdose deaths have more than tripled since 1990, universities are being confronted with this crisis through its students, yet more profoundly through the tidal wave of impact on student's families and surrounding communities. Annually the USA spends over \$600 billion every year due to addiction and the traditional age of college students is the most likely demographic to become addicted. With staggering facts like these, very few would argue that the country does not have an addiction crisis on its hands, yet does an institution of higher education have a moral obligation to address this issue? Can such things as theatre, art, music, language, English, film, history, classics, and religion address this crisis? Conference presentations ranged from the moral obligation of higher education to address addiction, practical responses through community organizations, student life for students in recovery, and humanities-based therapeutic and awareness programs. #### Description and Guidelines for Hosting a Regional Conference or Collaboration.

Regional Collaboration and Conferences Grants represent a flexible category of programs that encourage examination of topics of special significance to faculty, administrators, and students at a particular institution or group of institutions, or matters of special intellectual concern to faculty and others in Christian higher education. The focus, character, and constituency of the conference, collaboration, or workshop may vary to suit the needs of the applicant, within the general guidelines listed above. Previous successful conferences, collaborations, and workshops have focused on issues facing schools in a particular region, topics of current debate among faculty at a particular school, student life issues, graduate student matters, various theological or denominational traditions in higher education, an array of topics in liberal and professional education, and issues of civic and public concern to the Christian intellectual community. # Apply to hold an LFP Network Exchange

<u>Network Exchange Programs</u> allow Network institutions to showcase distinctive, signature projects, institutes, or curricula that highlight the Christian or church-related characteristics of their schools. They provide for an extended visitation by faculty and leaders from other Network colleges, allowing close observation and study of the pertinent program, so that other institutions might learn from the host institution's experience and perspectives.

Any established and distinctive institution, program, or curricular emphasis that especially promotes the college or university's mission and Christian character may be an appropriate focus for a Network Exchange. These may be programmatic initiatives like core programs, honors programs, interdisciplinary programs, or capstone courses. Or they might take the form of research or study institutes, international experiences, co-curricular programs, off-campus study centers, or service learning programs.

A Network Exchange program may be funded for \$25,000. The next deadline for applying for a Network Exchange in the 2022-2023 academic year is September 15, 2021. <u>Click here for more information about submitting a proposal.</u>
